## ACTIVITY AGREEMENT, WAIVER, AND RELEASE

\*\*\*READ CAREFULLY\*\*\*

\*\*\*THIS FORM AFFECTS YOUR LEGAL RIGHTS\*\*\*

In consideration for being permitted by First Light Church to participate in its youth basketball program (the "Activity"), I hereby waive, release, and discharge any and all claims for damages for personal injury, death, or property damage which my child may have, or which may hereafter accrue to my child, as a result of participation in the Activity. This Activity Agreement, Waiver, and Release (the "Agreement") is intended to discharge in advance First Light Church, its officers, employees, volunteers, and agents from any and all liability arising out of or connected in any way with my child's participation in the Activity, even though that liability may arise out of negligence or carelessness on the part of the persons or entities mentioned above. It is understood that the Activity involves an element of risk and danger of accidents, and knowing those risks, I hereby assume those risks.

It is further agreed that this Agreement is to be binding on my heirs and assigns. I agree to indemnify and to hold First Light Church free and harmless from any loss, liability, damage, cost, or expense which they may incur as the result of my child's death or any injury or property damage that my child may sustain while participating in the Activity.

### PARENTAL CONSENT: (To be completed and signed by both parents/guardians)

I hereby additionally consent that my son/daughter, \_\_\_\_\_, may participate in the Activity, and I hereby execute this Agreement on his/her behalf. I state that said minor is physically able to participate in the Activity. I hereby agree to indemnify and hold First Light Church free and harmless from any loss, liability, damage, cost, or expense which it may incur as a result of death or any injury or property damage that said minor may sustain while participating in the Activity. I understand that as part of my child's participation in the activity, photographs and video may be used for First Light Church promotion of the basketball ministry.

- I certify that I have read this Agreement in its entirety, understand the terms of this Agreement, have had sufficient time to ask questions, if any, regarding this Agreement, agree to be bound by the terms and conditions of this Agreement, and am giving up legal rights as a result of signing this Agreement.
- I am aware that this is a release of liability and a binding contract between myself and First Light Church. I acknowledge and agree that I am knowingly, willingly, and voluntarily, without any duress or coercion of any kind, signing this Agreement.
- I further Understand that no medical insurance is provided and no refunds will be given without the expressed written authority of First Light Church. Refunds must be requested 30 days prior to start of season's first practice. If the season is cancelled due to COVID-19, refunds will be given on a prorated basis.

If this agreement, or any part thereof, is found to be illegal or unenforceable in any way by court of competent jurisdiction, then the court may modify, interpret, or construe this agreement to make it legal and enforceable to the fullest extent permitted by law.

This agreement is made and entered into the State of Ohio and shall be enforce and interpreted under the courts and law of the State of Ohio.
